# Loup Service To District-Owned Street Lighting Systems

LOUP RIVER PUBLIC POWER DISTRICT

## AVAILABLE

This rate is available under a contract of standard form to communities, public authorities other than municipalities, and to customers within defined rate areas such as unincorporated communities and areas adjacent to communities in which the District is engaged in the distribution and sale of electricity.

#### APPLICABLE

To all night street lighting service (dusk to dawn) from District-owned overhead and underground distribution systems conforming with the District's standard specifications and allowable investments per unit.

#### **CHARACTER OF SERVICE**

The District will construct, own, operate and maintain the complete system and furnish street lighting service every night from dusk until dawn, or approximately 4,000 hours per year.

### FRANCHISE DISCOUNT

A discount of 33<sup>1</sup>/<sub>3</sub> percent shall apply on the above rates to cities and villages in which the District has a valid franchise.

#### **INVESTMENT IN EQUIPMENT**

The District will install, at is expense, additional street lighting units served from overhead or underground conductors, provided the average extension for each lighting unity added does not exceed 400 feet of conductor.

When the District is required to install an underground system which is not included in the rate, the customer shall contribute an amount equal to the difference between the cost of the overhead and underground systems. This contribution shall be a cash contribution or installation of a portion of the street lighting system as determined by the District.
